PBC Project Updates:

<u>Spotlight on Hinckley Allen Snyder LLP assisting the Transcending Through Education Foundation (TTEF).</u>

Hinckley Allen Snyder LLP partners **Malcolm Farmer** and **Avi Lev** are helping **The Transcending Through Education Foundation (TTEF)** get on its proverbial feet by providing the legal work and advice necessary to establish itself as a foundation and begin the important work its stakeholders have planned.

TTEF will provide resources and support for incarcerated individuals in Rhode Island to obtain a higher education. Through a powerful narrative of self-empowerment and giving back, the Foundation will work to reverse the School-to-Prison Pipeline and establish the Prison-to-School Pipeline. TTEF will provide two types of annual scholarships. One scholarship will be

awarded to a current inmate in the Rhode Island prison system pursuing his or her higher education. A second scholarship will be awarded to an inmate transitioning out of the Rhode Island prison system who will be pursuing his or her higher education upon release. In addition, TTEF will provide support services to scholarship winners.

<u>Edwards Wildman Palmer LLP re-ups its pro bono housing rights service</u> to Children's Friend RI

Our **Children's Friend** housing rights project, now in its sixth year, continues to provide housing conditions relief to those served by the organization through the hard work of **Edwards Wildman Palmer LLP** attorney **Erika Lindberg** and law students. In October, Erika Lindberg gave a presentation to the Children's Friend staff to spread the word about the PBC service and educate the staff on common legal issues related to housing. In January, the law firm will provide a more in-depth training to Children's Friend staff on common housing issues that can be prevented without the assistance of an attorney.


The PBC Celebrates National Pro Bono Celebration Week


