**Kiran Advani** has worked at the Circulation Desk since her first semester of law school. She works Mondays from 6:00 p.m. to midnight and Fridays from 4:00 to 10:00 p.m. Kiran's family immigrated to the U.S. Virgin Islands from Bombay, India when Kiran was eight years old.
