“Is There a Crisis in Appellate Military Justice?”



Over the last several years there has been a spate of military appeals—many, but not all, arising in the Navy and Marine Corps—in which extraordinary and indefensible post-trial delays have occurred. These cases have presented a severe challenge to the administration of appellate justice in the military, and have led to distortions in applicable doctrine as well as proposals for legislative change. Strong action is

called for by the Judge Advocates General, military commanders, and the bar. Whether remedial action by Congress is necessary or desirable is less clear. Join Eugene Fidell, former Coast Guard attorney and noted expert on Military Law, as he reviews these issues and potential reforms.

Law of Armed Conflict Address
