## RWU in Final Four of National Moot Court Competition

I am delighted to announce that a team of RWU Law 3Ls -- Nicholas Nybo, Will Wray, and Juliana McKittrick -- placed 4<sup>th</sup> in the National Moot Court Competition, the largest, and most prestigious appellate competition in the country <http://www.actl.com/Content/NavigationMenu/AboutUs/AwardsandCompetitions/NationalMootCourt/default.htm>. Over 196 teams from 131 schools compete in regionals, and after sweeping through a New England field that included Northeastern, Suffolk, Boston University, Syracuse, Boston College, Maine, Vermont, and Western New England, <http://law.rwu.edu/blog/rwu-team-wins-new-england-regional-national-moot-court-competition>, the RWU team joined 29 other teams in the Big Apple for the final rounds.

The case presented involved complex issues presented by a suit for damages against a police officer for violation of Fourth and First Amendment rights.

Nick and Will were the oralists; Juliana had taken the lead on the brief, and at the nationals Roger Williams knocked off #1 seed Utah en route to a Final Four appearance with Case Western, the University of Georgia, and Stetson, the eventual champ (that beat RWU by only a fraction of a point).

According to the faculty coach, Professor Diana Hassel, “Nick and Will were simply superb; the judges uniformly commented on how well-prepared they were and lauded their adept use of facts and case law.”

Will Wray commented:

We didn’t face a tougher judge panel than the one at school comprised of Nick's Con Law professor, my seminar professor, and our 1L legal writing professor.
