**What Does It Mean to be a “Real American?” –  
*Challenging the Criminalization of Immigration***



What does it mean to be a “real American,” and what happens if the door to our society is harder to open for some? Under the Obama administration, a record number of deportations has occurred -- over 1.1 million. Immigration and Custom Enforcement’s controversial Secure Communities Program (S-Comm) has contributed to a record number of deportations by automatically conducting immigration background checks on all fingerprints taken by local police at the point of arrest. The program began in 2008 and is slated to be active throughout the country by the end of 2012. S-Comm has been criticized for encouraging racial profiling and undermining community policing strategies. Learn about the Asian Law

Caucus’ work to push back against S-Comm and other programs that criminalize immigration and funnel more individuals into the already overcrowded criminal justice and immigration systems.

Fred Korematsu was probably never more American than when he resisted, and then challenged in court, the forced internment of Japanese-Americans during World War II. Korematsu lost his landmark Supreme Court case in 1944, but never his indignation and resolve. *Of Civil Wrongs and Rights* is the untold history of Korematsu’s long, remarkable journey from being a convicted criminal in 1942 to receiving the Presidential Medal of Freedom in 1998, and the 40-year legal fight that finally turned a civil injustice into a civil rights victory.
