In late September, we held our annual "Meet the Bay" trip with our 1Ls. The EU Issues a New Marine Spatial Planning Directive</u>," explores potential impacts of a new Directive on Marine Spatial Planning on ocean and coastal management in the European Union.

Another recent joint degree graduate, **Melissa Chalek '13**, presented the work she did as a URI Marine Affairs Fellow and Rhode Island Sea Grant Law Fellow on the Shellfish Management Plan (SMP) for the state of Rhode Island at a public stakeholders meeting in October. Melissa compiled all of the shellfish regulations and laws in the state of Rhode Island for the <u>SMP</u>. Leading up to her work on the SMP, Melissa researched shellfish relay in the state of Rhode Island for Rhode Island Sea Grant, and her findings were published in the *Sea Grant Law and Policy Journal*: "The Time Has Come...To Talk of Many Things: Legal Impediments to the Future of Shellfish Relay in the State of Rhode Island.

joint degree student **Adam Deitz** '14 each had two publications this spring and summer in *The Sandbar*, the legal reporter for the National Sea Grant College Program.
