## **Pro Bono Collaborative License Restoration Project Makes a Fresh Start Possible**

A driver's license can mean the difference between employment and unemployment or housing and homelessness. For many low-income people re-entering society, restoring their driver's license is the one most important step to getting back on their feet.

Recognizing the tremendous need for license restoration legal assistance, in January 2018 the Pro Bono Collaborative launched a project aimed at giving formerly incarcerated individuals a fresh start by helping them navigate the legal processes necessary to restore their Driver's Licenses. Andy Horwitz, Esq., Director of the RWU Criminal Defense Clinic, along with staff from the DMV's Operator Control and the Chief Magistrate of the Traffic Tribunal provided the necessary training to Whelan Corrente LLP attorneys who had signed on to participate. A Roger Williams University School of Law student also partnered on the project to support the work of the pro bono attorneys and

several community organizations that provide re-entry services screen and refer project clients. Among the community organizations are [Open Doors](#), [ManUp](#), the [Non-Violence Institute](#) and the [H.O.P.E. Federal Re-entry Court](#).

The project has been an invaluable resource for people facing the formidable obstacles associated with re-entry. As Andrew Horwitz, Esq. said of his pro bono license restoration work: “this is perhaps the most rewarding pro bono work I’ve done because restoring my client’s license is always a huge step forward in getting someone back on their feet. Driving leads to employment and provides a measure of independence that is critical for those facing re-entry.”
