## Spotlight on Student Library Employees - Part I

The Law Library employs students to work at the Circulation Desk and to assist with computer-related problems. Among their various duties, the Library Student Assistants working at the Circulation Desk check out and check in circulating items, answer telephone calls, troubleshoot problems with the photocopiers, file and shelve library materials, perform shelf reading, and shift books. The Computer Lab Monitors can answer basic questions about wordprocessing, email, electronic databases, and Internet. They can assist with printing problems in the computer labs.
