Mott House was an early 17th c. house located in Portsmouth, RI. During 1974/5 considerable study and documentation were done by several individuals and groups prior to, and during disassembly of the building. The physical building was lost to time and poor storage. The data was never completely finished nor centralized. NRF seeks to see work completed on the drawings by the original architect, all materials, photos, artifacts, articles, and drawings assembled and copies made available to several organizations which have a keen interest and following in architectural history. NRF is seeking funding to cover the cost of duplicating the original materials so that this significant history can be made available to a wider interested audience.

NRF has allocated funds to pay for the completion of the drawings, acquisition of the photographic materials, and staff time to accumulate written materials. We are seeking funds for duplication of materials for dissemination to historical and architectural organizations and well as universities.

This project will shed considerable light on 17th c. RI architecture for historians, architectural historians, archeologists, academics, and students of architecture and preservation. Through dissemination to various organizations many people will be able to study and learn form this project.
