Judge George Healy has dedicated his professional life to the safety and protection of Rhode Island's workers. Not only was he a respected judge on the Workers' Compensation Court for 25 years, he was a member of the task force that created the court in 1990 and ultimately reengineered the system in 1992.

Prior to his appointment to the bench, Judge Healy was an active civil litigator and workers' compensation practitioner. He was appointed to the Workers' Compensation Court by Governor Bruce Sundlun in 1991 and was sworn in as Chief Judge on August 27, 2004, by Governor Donald Carcieri. He served as Chief Judge until his retirement on July 31, 2015.

Chief Judge Healy remains a member of the Workers' Compensation Advisory Council, comprised of Rhode Island representatives from labor, business, state government, the insurance industry and the court. The council's mission is to advise the Governor and General Assembly on matters relating to workers' compensation. He served as a member of the editorial board for the *American Medical Association's Guides to the Evaluation of Permanent Impairment*, 5th Edition, and has lectured and published numerous articles on various aspects of workers' compensation law and practice.

Chief Judge Healy has served on the Board of Directors of the Institute for Labor Studies and Research and Roger Williams University's Pro Bono Collaborative. He has also taught workers' compensation law to future lawyers as an adjunct faculty member of Roger Williams University School of Law.

Judge Healy resides in East Greenwich, R.I., with his wife Ruth. They have two sons, Paul and Timothy Healy '05, and four cherished grandchildren.

MARIELENA HINCAPIÉ, ESQ.

Doctor of Laws, Honoris Causa

Executive Director, National Immigration Law Center

As executive director of the National Immigration Law Center, Marielena Hincapié is dedicated to defending and advancing the rights of low-income immigrants in the United States. Under her leadership, the NILC has become one of the country's premier immigrants' rights organizations, strategically employing a combination of litigation, policy, communications, and alliance-building strategies to effect social change.

Ms. Hincapie's both highly respected for her legal and political strategies and is seen as a bridge-builder, both within the immigrants' rights field and across broader social justice sectors. Fully bilingual and bicultural, she serves as a resource and is often interviewed by media outlets including Univisión, Telemundo, CNN en Español, MSNBC, *The New York Times* and *The Los Angeles Times*. She lectures frequently at national and international conferences, addressing issues of migration, and works closely with emerging leaders in the social justice movement.

Ms. Hincapié began her tenure at NILC in 2000 as a staff attorney leading the organization's labor and employment program. From 2004 to 2008, she served as NILC's director of programs. Before joining NILC, Ms. Hincapié worked for the Legal Aid Society of San Francisco's Employment Law Center, where she founded the Center's Immigrant Workers' Rights Project.

The recipient of many professional awards and honors, she has also served on the American Bar Association's Commission on Immigration; is currently a member of the Welcome.US and Center for Law and Social Policy (CLASP) boards of directors; and is board chair for the Indivisible Project. Ms. Hincapié immigrated as a child from Medellín, Colombia, to Central Falls, Rhode Island. She is the youngest of 10 children.
