Instructions to Authors

The *Journal* welcomes articles, comments, case notes, and book reviews concerning all aspects of maritime law, including the international law of the sea. Although the emphasis is on significant current issues, historical, theoretical, and other materials on these subjects are also accepted.

Except under unusual circumstances, it is the policy of the *Journal* not to publish material which has already appeared in, or is scheduled to appear in, other publications. Accordingly, any manuscript must be submitted on the understanding that the *Journal* has the exclusive right to publish it, and that the author will not submit it to other publications without first notifying the Editor that he or she intends to do so if it is not accepted by the *Journal* within a specified period following the date of the notice. If and when a manuscript is accepted it becomes the property of the *Journal*, and all copyrights will be taken out in the name of Jefferson Law Book Company. The publisher requires that each author sign the publisher's form of copyright transfer agreement, failing which a work will not be published. If the author has previously copyrighted the manuscript, acceptance for publication in the *Journal* will constitute an assignment of the copyright to Jefferson Law Book Company.

The general style of materials submitted for publication will best be understood by examining a recent issue of the *Journal*. All citations of cases, including those mentioned in the text, should be placed in the footnotes. Names of cases and other authorities (except statutes and treaties) should be italicized in the text, but not in the footnotes. Otherwise, citations should follow the style rules of the current edition of *A Uniform System of Citation* (the "Blue Book"), with the addition of citations to American Maritime Cases (AMC). It is preferable to leave all underscoring in footnotes to the Editor, except in quotations in which the judge or author has used italics, or where the author of the article wishes to use them for emphasis.

The manuscript should be submitted to the Editor as a Microsoft Word document attached to an email. The Editor's email address is on the inside front cover. The document should be double spaced. Footnotes may be included at the bottom of the page or as endnotes. Block quotations should be indented and quotation marks omitted. If graphics, such as photographs or charts, are included in the document, separate jpegs of each should also be attached to the email. The author should carefully check all citations and quotations before submitting the article.

The complete title of a manuscript, followed by the author's name and address, should be typed on the first page, and the text should start on the second page. A brief *curriculum vitae* of not more than four lines should be included as a first, unnumbered footnote. It will be helpful if the author suggests an abbreviated title to be used as a running head.

At the author's request, the Editor will provide a copy of the edited article prior to submitting it to be typeset. The author's comments and requested changes must be received by the Editor within 48 hours or the article will be submitted for typesetting with only the Editor's changes included.

Adherence to these rules will speed the editorial process, minimize printing costs, and lessen the possibility of error.
