### What are Brownfields?

According to the <u>EPA</u>, "a brownfield is a property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant." An example might be an old factory or abandoned business and the EPA estimates that there are more than 450,000 brownfields in the U.S.

In 2002, then President Bush signed the <u>Small Business Liability Relief and Brownfields Revitalization Act</u>, commonly known as the Brownfields Law which provides funds to assess and clean up these properties.

The newest book display in the library is on Brownfields and the books displayed are only part of the collection of resources highlighted on our <u>website</u>. The collection is also featured on the library's <u>Pinterest</u> page.

The <u>Environment & Safety Resource Center (Bloomberg BNA)</u> is an excellent source of news, analysis, cases, laws, and regulations related to the topic of Brownfields.

### February is African-American History Month

Whether you prefer to call it African American History Month or Black History Month, the tradition traces its roots back to 1915 in Chicago and a man named Carter G. Woodson. In 1976, President Ford issued the first Message on the Observance of Black History Month. In 1986, Congress passed Public Law 99-244. For more information about the legal history of this commemorative month, see the Law Library of Congress website.



Aside from researching the legal history of the month's designation, you might be interested in researching African American contributions to law. If so, the library has several resources on this topic. One example is the book <u>Showdown: Thurgood Marshall and the Supreme Court Nomination That</u> <u>Changed America</u>. Another example is the book <u>Rebels In Law: Voices in History of Black Women</u> <u>Lawyers</u>. There are also e-books available through the library's subscription to <u>ebrary</u> on this topic, such as <u>A More Noble Cause: A.P. Tureaud and The Struggle for Civil Rights in Louisiana</u> and <u>Crusader for</u> <u>Justice</u>.

Finally, you may be interested in reviewing legal scholarship specifically addressing economic, political, and sociological issues affecting African-Americans. There are a few law journals that match this description and are available on <u>HeinOnline</u>. For example, see the <u>Berkeley Journal of African-American</u> <u>Law & Policy</u> or the <u>National Black Law Journal</u>.

According to <u>Oceans Beyond Piracy</u>, maritime piracy costs billions of dollars a year. In <u>2014</u> alone, over 5000 seafarers were attacked by pirates. While many are familiar with the history of piracy in the Gulf of Aden, surprisingly, in 2012, the Gulf of Guinea surpassed it as the region with the highest number of <u>reported piracy attacks</u> in the world.
