On January 10th and January 11th from 11 am to 1 pm in the Law School Bistro, the librarians will be distributing information about the [Prepare for Practice Certification Programs](#).

The Prepare for Practice Certification Programs are [two certification programs](#). The legal research program is a free, online program via [Bridges](#) designed to refresh and enhance students' legal research skills. If you complete the research certification program requirements, you can receive a Certificate in Legal Research Skills for Practice.

The technology program is also free and taught in the Law Library throughout the semester. You can view the [calendar of class dates online](#). If you complete the technology certification program requirements, you can receive a Certificate in Basic Technology Skills for Practice.

Both of these certificates can help distinguish your resume from others.

Not only will the librarians be passing out information, but they will also be serving hot chocolate!

## Visit from Justice Ruth Bader Ginsburg



Make way for the [Notorious R.B.G.](#)!

On Tuesday, January 30 th U.S. Supreme Court Justice Ruth Bader Ginsburg will be visiting the RWU School of Law for a “fireside chat” with 1st U.S. Circuit Court of Appeals Senior Judge Bruce M. Selya.

Justice Ginsburg, the second woman appointed to the Supreme Court, has served on the Court since 1993. She has long been a pioneer for women in law, starting during her days at Harvard Law where she became the [first woman](#) to serve on the Harvard Law Review. As [Dean Michael Yelnosky has said](#), “It is hard to overstate the impact Justice Ginsburg has had on American law and specifically on gender equality. Before she became a judge, she brought cases before the Supreme Court that first established the principle that government discrimination against women violated the Constitution’s equal protection clause. As a Supreme Court justice, she and her colleagues have built on that foundation a jurisprudence ensuring women ‘equal opportunity to aspire, achieve, participate in and contribute to society based on their individual talents and capacities.’”

In preparation for the upcoming visit of Justice Ginsburg, the Law Library has created a [book display](#) devoted to works written by and about this historic figure.

In addition to the display, the Library also has additional resources for finding more information about Justice Ginsburg and for researching the Court and other “Supremes.” One such resource is Bloomberg BNA [United States Law Week](#), where you can access opinions, news about and transcripts of oral arguments, reviews of past terms, previews of upcoming terms, and much more. They even have [podcasts](#) that you can tune in to on your way to school or your internships!

- Audio: Sum & Substance and Law School Legends.
