### **MAI Graduate Jobs!**

When I meet with prospective students interested in marine affairs, they often ask me what kind of jobs our graduates have. It's a great question and one that I love answering. Our graduates can be found all over the country working in diverse marine affairs jobs.

Some of our graduates leave RWU Law to work at top-ranked admiralty and maritime focused law firms. Two graduates of the class of 2015 are part of that group. Patrick O'Connor can be found at Hill, Betts, & Nash, LLP in New York, New York. During his time at RWU Law, Patrick was a legal intern at the Waterfront Commission of New York Harbor and a legal extern at Dominica Maritime Registry, Inc. Patrick also participated in the Judge John R. Brown Admiralty Moot Court Competition while at RWU Law. His teammate for the admiralty moot court, Casey O'Brien, can also be found in New York City these days. Casey just started working at Hill Rivkins, LLP. In addition to participating in the moot court competition, Casey served as a Rhode Island Sea Grant Law Fellow at RWU, working with Save the Bay to analyze coastal development in Rhode Island. Casey also volunteered at Clean Water Action in Providence, and interned at the Rhode Island Attorney General's office and Moran Shipping Agencies, Inc. (with alum Gavin Black '10), and received the Marine Affairs Institute Achievement Award. At Hill Rivkins, Casey joins fellow RWU graduate Brian Eisenhower '09.

A little further from campus, **Nicholas Paine** '12 is making a name for himself in admiralty and maritime law in Houston, Texas. Nick is an Associate Attorney at the firm Schouest Bamdas Soshea and BenMaier, P.L.L.C. During his time at RWU Law, Nick was a Rhode Island Sea Grant Law Fellow. He did

in-depth research for our Marine Affairs Institute Symposium on the Deepwater Horizon Blowout. Now he lives and works in the Gulf!

A little closer to home, our former graduates are becoming great leaders in the State of Rhode Island. **Marisa Desautel**, a 2006 joint degree graduate, opened her own environmental law firm in Providence, the Law Office of Marisa Desautel, LLC, last year. After RWU Law, Jackie served as a Presidential Management Fellow for NOAA. If you are a prospective student interested in working with Jackie, I have good news! RWU Law has a summer internship placement with NOAA's Office of General Counsel, Ocean and Coasts Section (an internship that Jackie held as a student at RWU Law). In addition to the other perks of her job, Jackie now gets to give the next generation of RWU Law students the opportunities she had while at RWU.

Also making a great name for herself in DC is **Sarah Lim**. Sarah is the Chief Counsel for the House Natural Resources Committee, Democratic Staff. After graduating from RWU Law, Sarah served as a John D. Knauss Legislative Fellow for the House Natural Resources Committee.
