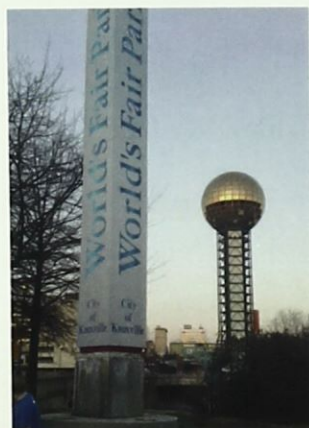

INTRODUCTION

Alternative Spring Break (ASB) was started in 2005 by the Association for Public Interest Law (APIL) at Roger Williams University School of Law in the wake of Hurricane Katrina as a way for students to assist those recovering from devastation.

Since then, ASB has grown into a large and successful program matching students to local and national public interest legal projects during spring break. The program focuses on areas of the law where clients often lack adequate representation and works to secure projects that give students the most rewarding experience possible. The 2015 program was one of the largest and most successful in history. We had almost 50 participants working on 17 different projects in 7 states.

This report is respectfully submitted by the APIL Board and details the projects and experiences of this year's participants. The Board is deeply appreciative of the efforts of the entire Roger Williams University School of Law community in making this year's program a success.

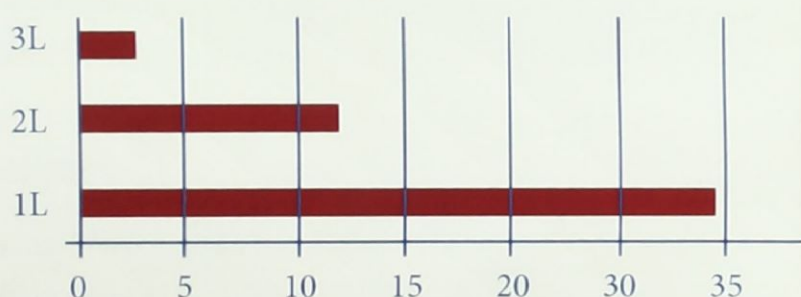

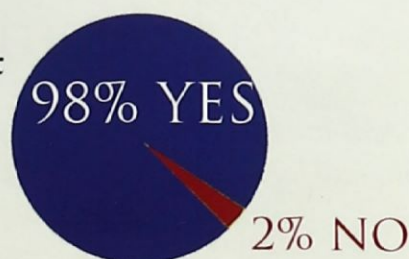

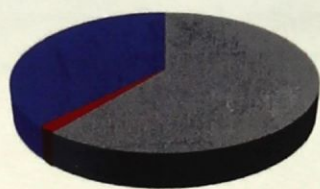


2015 ASB PARTICIPANT FEEDBACK
